**Health Plus premiums are tax-deductible if you're self-employed. This means your actual net cost is much lower than the quoted rates.**

For example, using Ontario tax rates if you earn \$51 000 your top dollar tax rate is 30%. Your real cost for Optimum Single coverage goes down from \$116 to \$82 a month. At higher income levels and tax rates, the net cost for your Health Plus plan could go down by almost 50%.
